How 100+ MEN ON A MISSION Works	To the Presenters
Each member must commit to donating \$100 per meeting (\$400 per year).	Please do your homework!
The donations will be given to Des Moines Metro charities/non-profits/worthy causes serving the Des Moines area only.	First, talk to the organization you wish to support (preferably the director or president). Verify that it is a 501 (C)(3).
The purpose is for the contribution to stay 100% in the community. Each charity/non-profit/worthy cause that is under	Get a commitment from them that they will NOT add us individually to their donor list or any other solicitation.
consideration will be given five minutes to make a presentation at the meeting by a member of the 100+ MEN ON A MISSION, not by the charity/non-profit/worthy cause.	Gather all facts or statistics you can provide the group. We want to make an educated decision. Remember, you only have 5-minutes to present and another 5-minutes to answer questions.
Three charities/non-profits/worthy causes will be presented at the meeting. The group will vote by ballot and majority rules. Although it may not be your first choice, you are still obligated to donate.	Presentations are NOT to include multi-media e.g. PowerPoint slides. Rather, come prepared to speak from the heart. Handouts are acceptable.
If your name is drawn and you make a presentation and your charity is not chosen, you will still be eligible to put your name in the drawing at the next meeting.	If the charity is financially supported or affiliated with a national group there must be a commitment that all dollars remain in the metro area.
For tax purposes, all checks will be made out to the chosen organization. If you are unable to attend, give your check to a member to deliver on your behalf.	If this is a worthy cause instead of a charity, is it still tax deductible? If the charity/cause is NOT tax deductible, you MUST inform the group during your
The charity/non-profit/worthy cause must agree to NOT use the donors' names for future solicitations or give the information out to the public. If the charity/non- profit/worthy cause does not adhere to this condition, they will be removed from any future consideration.	presentation and before a vote is cast. Come prepared! You are responsible for our member's donations.
